- H. A person who would not be disqualified from receiving the license applied for hereunder by reason of any matter or anything contained in the laws of the State of Illinois or any ordinance of the City of Countryside;
- I. Incorporated in Illinois, or unless it is a foreign corporation which is qualified under the Illinois business corporation act, to transact business in Illinois;
- J. A corporation whose place of business is not conducted by a manager or agent unless said manager or agent possesses the same qualifications required of the licensee;
- K. A person who has not been convicted of a violation of any federal or state law concerning the manufacture, possession or sale of alcoholic liquor, subsequent of February 11, 1970, or who has forfeited a bond to appear in court to answer charges for any such violation;
- L. A person who does not beneficially own the premises for which a license is sought or does not have a lease thereon for the full period for which the license is to be issued;
- M. A person who is not a law enforcing public official, Mayor, Alderman, or member of the City Council of the City of Countryside;
- N. A person who has not been convicted two or more times of a gambling offense as proscribed by Illinois Revised Statutes, Chapter 38, Section 29-1, (a) (3) through (a) (10);
- O. Not a person who fails to present proof of dramshop insurance as required by Ord. 90-41-O.
