

**CITY OF COUNTRYSIDE
CHICAGO WHITE SOX VS. CHICAGO CUBS
BOX SEAT TICKET PROMOTION OFFICIAL RULES**

THE PROMOTION WILL RUN FROM THURSDAY, JUNE 28, 2018 THROUGH SATURDAY, SEPTEMBER 8, 2018. ENTRY FORMS ARE AVAILABLE AT ALL COUNTRYSIDE CAR DEALERSHIPS DURING THEIR REGULAR BUSINESS HOURS. NO PURCHASE IS NECESSARY.

ALL ENTRIES MUST BE RECEIVED BY CLOSE OF BUSINESS ON 9/8/18.

1. **HOW TO ENTER:** Complete an Official Entry Form available at all nine (9) car dealerships located in the City of Countryside. For a complete listing of the car dealerships visit our website at www.countryside-il.org or visit the City Hall at 5550 East Avenue, Countryside, Illinois 60525. Entry forms must be deposited in one of the promotion boxes located at each dealership. No illegible, incomplete, forged, or altered entries will be accepted. Limit one (1) entry per person. No purchase necessary. All entries become the exclusive property of the City of Countryside (“Sponsor”) and will not be returned.
2. **SELECTION OF WINNER:** The winner will be determined from all eligible entries received in a random drawing to be conducted at the City Council meeting on Wednesday, September 12, 2018 on or about 7:30 p.m. by the current Mayor of the City of Countryside whose decisions are final on all matters relating to this Promotion. The winner will be notified by email at the address indicated on the entry form (or one telephone call/message at the number indicated on the entry form) on Thursday, September 13, 2018, with one follow-up telephone call/message on Monday, September 17, 2018, and a second follow-up on Tuesday, September 18, 2018, at the telephone number indicated on the entry form.
3. **PRIZES AND ODDS:** One (1) winner will be selected to receive 4 tickets to a Chicago White Sox vs. Chicago Cubs crosstown game in September, 2018. Odds of winning depend upon the number of eligible entries received. Sponsor reserves right to substitute prize of equal or greater value. The winner may not transfer or substitute their prize, but may bring three (3) guests to use three of the four tickets won. The winner may either pick up their tickets at City Hall or they will be mailed after the affidavit of eligibility and liability release is received.
