Mayor McDermott: You have the floor.

Mr. Krzeminski: Thank you, very much, Mayor. Don't want to run too long – but, City Council is supposed to be looking into the future where the government runs as it is. If it wasn't for our – for our forward thinking Council years ago, I wouldn't be in Countryside at all. Ward 2 was annexed years ago back in the '70s. When they went in they also put in oversized water line because they figured that eventually Fisher Body would be turned over and they would have sufficient water. The reason I'm asking this is that the Mayor – did you ever get contacted by Edgewood Valley Country Club to be annexed into Countryside?

Mayor McDermott: We were not – not to my recollection. Gail? No.

Ms. Paul: No. We were not.

Mr. Krzeminski: You were not. Hmm, because that was reported that by – Edgewood Valley Country Club that they contacted all the communities around us. When I was Mayor I had a meeting with Edgewood Valley to let them know that if we would be – I would entertain, as far as annexing, because we do supply water to them. Now Edgewood Valley is going to be up for a vote to be annexed by Burr Ridge. I'm surprised, and I'll find out why we weren't contacted. Thank you. That's all I have to say.
